



CAJA DE ARTE – COVID SAFETY

We will follow all CDC guidelines - be aware that our rules can change according to LA Department of Health Guidelines and any time before or during the camp season.

SCREENING AND SANITARY PRACTICES

- Students and staff complete daily health inquiry before being admitted to camp. Any staff members or students who are ill (even non-covid-related) will not be admitted to camp.
- ALL staff will be fully vaccinated, boosted and past the 2 week waiting period by the time camp starts.
- Our faculty, staff and all students will practice expert hygiene including frequent handwashing - between activities, before lunch, before and after bathroom use.
- All surfaces will be sanitized throughout the day
- Any supplies that need to be shared between classes will be sanitized by the staff

CAMPER COHORTS

- Each individual class has no more than 10 – 12 kids
- Each class has a minimum of two staff members at all times in case one adult needs to leave the room or play area
- Each area will be cleaned before camp and at every break.

MASKING AND COVID SAFETY

- All students and staff are masks-optional. If your student will be masking up please let us know if that is indoors only, and please provide extra masks.
- Students bring their own snacks and lunch to camp and there will be no sharing of food for safety reasons.

LIABILITY WAIVER

Vox Box Arts Collective will conduct its summer camp program in June 2024. I/we understand that VBA is doing everything in their power to protect my child/student and/or me from risks of contracting covid. I/we realize there are natural, mechanical, and environmental conditions and hazards which independently or in combination with any activities engaged in while participating in this program may result in the exposure to certain risks including exposure to covid 19 or other biological agents, virus or similar bacteriological agent.

I commit to disclosing any possible risk (covid exposure) that I am aware of outside the camp setting that could put anyone at camp at risk. I hereby agree not to enter Caja de Arte nor permit my child/student to enter the campus if I/they have exhibited or been in contact with another person who has exhibited any of the symptoms currently listed by the Center for Disease Control and Prevention within the previous 14 days.

I hereby state that I, on behalf of my child/student and myself, am an adult, over the age of 18, and legally competent to sign this form. I understand these inherent risks and dangers involved with participation in the school providing their summer camp services and acknowledge the existence of risks which are not obvious or predictable, and hereby intend this release to extend to injury or loss which results from both obvious or predictable risks, as well as risks that are unpredictable and not obvious and to extend to myself and my child/student, as applicable.

I hereby agree to have the temperature of my child/student checked daily before/while on property of CRBC/CRCS.

In consideration of myself and my child/student, I/we, and any legal representatives, heirs and assigns, hereby release, waive, and discharge Vox Box Arts, its officers, directors, employees, agents, and representatives from all liability for any loss or damage, and any claim or damages resulting therefrom, on account of any injury, illness or exposure to and/or contracting any biological agents, virus or similar bacteriological agent by me or my child/student.

I HAVE CAREFULLY READ THE FOREGOING RELEASE AND KNOW AND UNDERSTAND THE CONTENTS THEREOF. I SIGN THIS RELEASE VOLUNTARILY AS MY FREE ACT WITH FULL KNOWLEDGE OF ITS SIGNIFICANCE, INTENDING TO BE LEGALLY BOUND THEREBY.
